RETAINERS will be requested based on magnitude of casework anticipated. Retainers may be waived based on past experience with clients. A \$750.00 non-refundable initial consultation fee will be charged on all new cases. Clients should expect \$2,500 - \$5,000 retainers.

INVOICES - All Invoices are due and payable immediately upon receipt. All billing statements (current and/or past due) must be paid prior to the issuance of a report, providing a deposition and or trial testimony. After 30 days, interest will be charge at a rate of 1½ % per month on any unpaid balance. Clients will be billed periodically during the investigation to maintain a current status on charges.

DEPOSITIONS AND TRIAL APPEARANCES - Deposition and trial appearance fees must be arranged for and agreed to prior to the appearance. Associated expenses will also be pre-paid unless other agreements are made, i.e., travel expenses such as mileage, hotel, meals, air travel, rent car, etc.

Local Deposition or Trial Appearance Charge - 3 hour minimum \$825.00
Out of Town Deposition or Trial – Day rate \$2200.00

If an out-of-town deposition requires travel the day before or the day after, charges will be incurred at the normal hourly rate unless travel occurs on weekends or holidays at which time the weekend/holiday rate will apply.
